Calgary Changemaker School is proud to offer a needs-based Financial Assistance Program. We understand that tuition can be cost-prohibitive for many families and we know that Changemakers come from all backgrounds. We also want to encourage siblings to attend. Therefore, we are offering a sliding scale financial aid program based on need.

In order to be considered for financial assistance, all families must complete an assistance application form. All completed forms must be submitted to Calgary Changemaker School's CFO in confidence prior to **March 1st** each school year to be considered for the following September. Our CFO will review your application within 30 days of submission. All information submitted is protected and confidential.

If your family qualifies, the results will be communicated to the applicant immediately after assessment and will include how much financial aid we will be able to offer the applicant family in the upcoming school year.

Due to limited resources and funding, we are not able to offer financial aid to all applicants who qualify. Priority goes to families who have attended our school for at least one year and for the siblings of existing students.

We are unfortunately unable to accept financial aid applications after the March 1st deadline.

Basic Guidelines & Instructions

All assistance is based on need and is determined by the CFO at Calgary Changemaker School.

Financial Assistance funds are limited and all successful applicants will be required to pay a minimum amount of tuition as determined by the CFO in addition to the one-time \$2500 capital fee and annual technology/activity fee. Families must first apply to the school and pay the \$100 application fee. Not all applicants will automatically be eligible for financial aid.

A new application for financial assistance must be submitted for each school year. If applying for more than one child in your family, please list the students' names on the Calgary Changemaker Student Information section. Only one application needs to be completed per family.

All applicants must complete the application in full and will be expected to provide all necessary documentation as requested. A Notice of Assessment(s) from Canada Revenue Agency will be required. The CFO reserves the right to request additional information from any applicant. Please note that all information will remain strictly confidential.

Deadlines

All applications must be submitted by March 1st to be eligible for the following school year.
